NJEDA Report and Food Desert Relief Program

The New Jersey Economic Development Authority (NJEDA) has released a list of New Jersey's 50 designated Food Desert communities. The Food Desert Relief Program addresses the food security needs of communities across New Jersey by providing up to \$40 million per year in tax credits, loans, grants, and/or technical assistance to increase access to nutritious foods and develop new approaches to alleviate food deserts.

Food Security Planning Grant Program

To advance the goals of the Food Desert Relief Act (FDRA), part of the Economic Recovery Act of 2020, the EDA will use up to \$1,500,000 in economic planning services funds to create a competitive planning grant program focused on leveraging distressed assets in designated Food Desert Communities (FDCs) in New Jersey to improve food access and food security.

Citi Foundation Community Finance Innovation Fund Request for Ideas

The Citi Foundation has announced a \$50 million Request for Ideas (RFI) to support the next level of growth for Community Development Financial Institutions (CDFI) industry through the creation of the new Community Finance Innovation Fund. The Fund supports intermediary-like nonprofit organizations with the ability to provide technical assistance and capacity-building innovations to multiple CDFIs working on a national or regional basis. There is no identified maximum or minimum grant size defined for this opportunity, although the Foundation anticipates it will ultimately provide grant support to 10-20 ideas as part of the Community Finance Innovation Fund and that the amount of funding for each idea will vary depending on the scope and scale of the ideas submitted.

The BUILD Health Challenge

The BUILD Health Challenge seeks to support communities in their efforts to advance health equity—to ensure that no one is disadvantaged from achieving their full health potential because of social position or other socially determined circumstances. The BUILD Health Challenge will support up to 19 awards of up to \$300,000 each, over a three-year period, to put their **bold, upstream, integrated, local, data-driven** plans into action. New Jersey communities of 100,000 residents or more are eligible to apply for the four awards designated for cities from any U.S. state or territory.
